## HOW DO I GET PAID?

The Cash program has some specific rules, and there is a difference between the "Current balance" and the "Payable balance". Everything in the "Current balance" is what you've generated. Everything in the "Payable balance" is what can be paid to you (according to conditions on point 3)

### CURRENT BALANCE

**\$3902.84**

Last 3 months revenue reserve:  
20% of \$163.00 = \$32

### PAYABLE BALANCE

**\$2111.86**

6+ month revenues: \$2111.86

We are reserving 20% of your last 3 months revenue in case you have a lot of chargebacks. This rule has been made in order to protect the cash program, in case a lot of chargebacks come during the month after the revenue generation and payment.

You have to wait until the 7th month from the moment you generate an income, to have this income passing from "Current balance" to "Payable balance". Here is an example:

In this example, you started to promote our content in January 2022 and you generated \$50. To have this \$50 as the **maximum payable balance amount**, you need to wait until the 7th month, so here, it will be August 2022. And then, in September, your **maximum payable balance** will be January + February's revenue, so \$150 (minus the 20% of the reserve we mentioned in point 1) and so on.

This means that if you generate \$200 per month from August 2022, you can receive this \$200 every month from October 2022 because at this time, your maximum payable balance will be \$200.

In order to get paid by SexCash, you must:

- Have a payable balance that reaches the minimum payout - \$500 for bank wire payments; \$300 for Paxum payments.
- Have an updated SexCash account (email address validated, correct payment information, VAT number if you are an EU company, address etc...)
- In case you are a Czech based company, we will have to contact you, as we are Czech company too, and request your invoice in order to have the same accounting documents towards the Czech authorities.

## HOW DO I GET PAID?

All the money generated by your profile is due to you, we are not keeping it indefinitely, it belongs to you and is paid to you.

If all these conditions are filled, SexCash payouts are validated automatically by our admin team around the 15th of each month, targeting a payment around the 17-18th of each month.
